

# Terms of reference – Specialist Contractor

# Role title: Chair - Global Creative Economy CouncilApply by:22nd April 2025

#### 1. Background and context about the project

The British Council and Creative Industries Policy and Evidence Centre (Creative PEC) are the convening partners of the Global Creative Economy Council (GCEC) – a unique forum for global creative economy policy and practice. <u>The GCEC</u> grew out of the Creative PEC <u>International Council</u> that was launched in 2018 and evolved to become the GCEC in 2023.

The GCEC brings together academics, practitioners, policy professionals and investors from five continents to identify and discuss emerging trends of global significance in creative economy policy and practice. In particular, it aims to provide inclusive perspectives on global policy issues that span both Global South and Global North, and consider ideas for transnational and multilateral policies and standards. The GCEC is funded by the British Council and Creative PEC and contributes to the work of both organisations by providing targeted insights and related research.

#### 2. About the role of the specialist contractor

This is a unique opportunity to shape and lead strategic work with influential figures in the creative industries from around the world. It is also an opportunity to steer the work of the Global Creative Economy Council into a new phase of development. The

# successful applicant will need to demonstrate in concrete terms how they will work with the British Council and Creative PEC to meet its global and transnational policy vision.

The Chair will set the agenda and lead the GCEC's regular online meetings as well as the annual meeting and wrap around programme. The Chair may also lead ad hoc meetings that support the work of the GCEC.

The Chair will lead the GCEC in contributing to ideas for transnational and multilateral policies that aligns with the strategic priorities of the British Council and Creative PEC and furthers the work of these two organisations.

The Chair will identify and present relevant policy provocations for debate at GCEC meetings and lead the GCEC in producing for publication written outputs on these themes, including research, blogs and articles.

The Chair will elevate the influence of the GCEC through identifying opportunities for global policy impact and through strategic partnerships and collaboration.

The Chair will work in collaboration with the British Council and Creative PEC to ensure the GCEC provides return on investment and impact for the UK and internationally.

The Chair will provide a quarterly update statement on the progress and achievements of the GCEC.

# 3. Outcome and output

- Chairing the GCEC meetings and ensuring they are well run and focused
- Coordinating and overseeing delivery of agreed GCEC outputs such as research and blogs.
- Leading planning for the annual face to face meeting of the GCEC, setting clear aims and objectives and ensuring it is well positioned for policy impact opportunities in the local context.
- Linking the discussions and work of the GCEC to the Creative PEC's international research and policy priorities.

- Linking the work and discussions of the GCEC to the aims of the British Council's Creative Economy Programme.
- Running regular strategy monthly meetings with Creative PEC and British Council.

#### 5. Fee & expenses

The annual fee of £10,000 will cover regular online meetings, the development of face-toface meetings, and collaboration with Creative PEC and the British Council.

The fee is all inclusive other than specifically agreed travel and expenses related to an annual meeting. The above fee is for providing that year-round leadership of the GCEC as Chair; we anticipate that requiring the equivalent of approximately 25 days.

- Demonstrable track record of working with academics, practitioners, policy professionals and investors.

- Experience of writing and editing papers and contributing to shared knowledge on issues related to the creative economy.
- Experience of representing and advocating on public platforms.
- Knowledge of influencing policy internationally.
